Although the Argentinian authorities have instructed all foreigners to regist the majority have not done so for fear of reprisals. On 10 June, a list of refugees was stolen from the refugee agency in Buenos Aires. The next day, 25 (mainly Chilean) were abducted from two hotels in Buenos Aires. They were fre. 24 hours later, tut all had been tortured. Protection therefore, even for recognized refugees is totally inadequate.

Some of the refugees are accused of having no documents or false ones. .s many have had to flee their native country because of political persecution, they are unable to obtain the necessary papers. In other cases, governments refuse to renew the passports of political exiles, which effectively means that they are stranded in Argentina.

Prisoners are often allegedly tortured at the investigation stage. From information received, it would seem that once detainees are transferred to Villa Devoto, they are not in actual danger.

The detained Chileans are in a comparably better condition that the Argentinians. They are not in isolation, but are not allowed visitors. Food appears to be passable.
