SUBJECT: ALLEGED TORTURE OF ARGENTINE CITIZENS IN PARAGUAY

1. EMBASSY HAS CONFIRMED THAT ENRIQUE OSVALDO LANDI AND HIS WIFE, OFELIA BADIO DE LANDI, ARE STILL BEING HELD BY PARAGUAYAN INVESTIGATIONS POLICE AFTER BEING DETAINED MORE THAN ONE MONTH AGO. IT ALSO SEEMS CLEAR THAT THESE TWO PEOPLE HAVE BEEN SEVERELY TORTURED BY TWO ARGENTINE SECURITY OFFICIALS AIDED BY THE PARAGUAYAN POLICE. THEIR THREE YEAR OLD SON, ENRIQUE LANDI, HAS DISAPPEARED. HUMAN RIGHTS ORGANIZATIONS HAVE ASKED THE GOP TO TURN THE CHILD OVER TO THEM FOR PROPER CARE. THE ORGANIZATIONS BELIEVE, HOWEVER, THAT THE CHILD IS BEING TAKEN CARE OF IN THE HOME OF AN INVESTIGATIONS POLICE OFFICIAL. THE HUMAN RIGHTS GROUPS ALSO HAVE INFORMATION THAT THE LANDIS WERE INVOLVED IN SOME TYPE OF ILLICIT POLITICAL ACTIVITIES.

2. JUAN CARLOS SILVA AND HIS FATHER, RAMON SILVA, HAVE BEEN RELEASED BY THE POLICE AND THEY HAVE TOLD THE COMITE DE IGLESIAS THAT THEY WERE NOT TORTURED. IN ADDITION, THERE IS GOOD INFORMATION THAT SEVERAL OTHER ARGENTINE CITIZENS HAVE BEEN EXPELLED FROM PARAGUAY.

3. OUR BEST INFORMATION INDICATES THAT URUGUAYAN SECURITY FORCES WERE NOT INVOLVED IN THESE ACTIVITIES AND THAT THE ONLY URUGUAYAN CITIZENS DETAINED WERE SPOUSES OF SOME OF THE ARGENTINE NATIONALS.

4. COMMENT: EMBASSY'S JUDGEMENT IS THAT THE DETENTION OF ARGENTINE CITIZENS WAS ONLY CONNECTED WITH THE ACTIVITIES OF THE LANDI COUPLE AND HAD NOTHING TO DO WITH VISITS BY HIGH LEVEL ARGENTINE OFFICIALS SUCH AS GENERAL VIOLA. EMBASSY IS ADDING THE NAMES OF LANDI AND HIS WIFE TO ITS LIST OF POLITICAL PRISONERS.
