(U) JULY 3 EDITION OF LEFTIST DAILY "EL DIARIO DE MARKA" PUBLISHED IPS WIRE SERVICE ITEM DATELINED LA PAZ IN WHICH PRESIDENT LYDIA GUEILER IS QUOTED AS SAYING THAT THE RECEIPT GIVEN BY THE GOB FOR RECEIVING FIVE (SIC) "MONTONEROS" FROM THE GOP" HAS NO VALIDITY BECAUSE IT WAS OBTAINED UNDER PRESCURE." (COMMENT: IT IS NOT CLEAR FROM THE ARTICLE WHETHER MRS. GUEILER ACTUALLY SAID FIVE "MONTONEROS" OR WHETHER IT PERPRESENTED LITERARY LICENSE ON THE PART OF IPS.) SAME EDITION OF "EL DIARIO DE MARKA" ALSO PEPOPTED THAT PERUVIAN PRIME MINISTER RICHTER HAD REFUTED THE EARLIEP STATEMENTS OF THE BOLI IAN PRESIDENT AND MINISTER OF INTERIOR TO THE EFFECT THAT THE GOB HAD NOT PECEIVED THE APGENTINES.

2. (U) "EL DIAPIO DE MARKA" ALSO PUBLISHED REMARKS MADE JULY 2 AT LIMA AIRPORT BY BOLIVIAN MINISTER OF A GRICULTURE MARIO VIZCARPA AYALA WHICH INCLUDED HIS STATEMENT THAT THE GOB IS "WAITING FOR A COMPLETE AND ACCURATE CLARIFICATION" OF THE MATTER EROM THE GOP. VIZCARRA ALSO SAID THAT "THE INVESTIGATION OF THE CASE CONTINUES UNDER THE DIRECTION OF THE (BOLIVIAN) MINISTRY OF INTERIOR, MIGRATION, AND JUSTICE" AND THAT THE GOB HOPES THAT A CLARIFICATION WILL BE MADE SOON SO THAT "THE EXCELLENT RELATIONS BETWEEN THE TWO COUNTRIES MAY BE MAIN-TAINED WITHOUT VARIATION."

ALSO RUOTED IN JULY 3 EDITION OF TEL DIARIO DE MARKAT WAS THE DESIGNATED MINISTER OF WAR IN THE BEALUNDE CABINET GEN (R) JORGE MUNIZ LUNZ, WHO STATED THAT PRIME MINISTER RICHTER HAD SHOWN HIM A PHOTO OF THREE PERSONS (INCLUDING TWO WOMEN) AT THE MOMENT THEY WERE DELIVERED TO BOLIVIAN AUTHORITIES AT THE BORDER NEAR DESAGUADERO. (COMMENT: UNHOR LIMA REP DA CUHNA TOLD EMBASSY HUMAN RIGHTS OFFICER JULY 2 THAT HE WAS SHOWN A PHOTO SHOWING 3 PERSONS WITH HANDS CUFFED BEHIND THEIR BACKS, HEADS BOWED, AND STANDING AT A DISTANCE WHICH PREVENTED A CLEAR IDENTIFICATION OF THEIR
