SUBJECT: SECOND MEETING WITH CHIEF OF STAFF RE LETELIER CASE

REF: ASUNCION 4375

1. ON OCTOBER 11 I CALLED AGAIN ON CHIEF OF STAFF GENERAL ALEJANORO FRETES DAVALOS. AFTER PRELIMINARY COURTESIES, HE READ HE THE ACTA OR SUMMARY MINUTES RESULTING FROM THE VISIT OF GENERAL OROZCO, CHIEF OF CHILEAN INTELLIGENCE, TO ASUNCION. THE DOCUMENT ITSELF MAKES NO DIRECT REFERENCE TO THE LETELIER CASE. FRETES SAID THE PRESIDENT HAD AUTHORIZED WIN TO BRIEF ME ON THE ACTA BUT HE PREFERRED TO READ IT VERBATIM.

2. THE DOCUMENT IS BASICALLY AN AGREEMENT TO COORDINATS ALL INTELLIGENCE RESOURCES IN ORDER TO CONTROL AND ELIMINATE SUB-VERSICH. IT SPEAKS OF EXCHANGE OF INFORMATION, PROMPT USE OF COMMUNICATION FACILITIES, MONITORING OF SUBVERSIVES AND THEIR DETENTION AND INFORMAL MAND OVER FROM CHE COUNTRY TO THE OTHER. IT REPEATS OVER AND OVER THE NEED FOR FULL COOPERATION AND MUTUALLY FACILITATIVE ACTS IN THE CON-TEXT OF A FIGHT TO THE DEATH AGAINST SURVERSION.

3. IN RESPONSE TO MY CUESTIONS, FRETES DAVALOS GAVE THE FOLLOWING ACCOUNT OF THE MEETING BETWEEN CHIEF AND PARACULAY, IT WAS SIMPLY AMOTHER IN A REGULAR SERIES OF MEETING WHICH TAKE PLACE ANNUALLY AMONG THE CHIEFS OF INTELLIGENCE OF THE COUNTRIES OF THE SOUTHERN COME. THIS SYSTEM OF CONSULTATIONS CAME INTO BEING MAINLY AS A DEFENSE AGAINST THE THREAT OF ARGENTINE SUBVERSION SPREADING TO OTHER COUNTRIES. BRAZIL, ARGENTINA, CHILE, SOLIVIA PARAGUAY AND URUGUAY MAKE OF THE NET ALTHOUGH URUGUAY IS NOW ALMOST ON THE INACTIVE LIST, FRETES DAVALOS SAID THE MEETINGS ARE NOT PARTICULARLY USEFUL ANYMORE. IN HIS JUDGMENT, BECAUSE THE MAIN THREAT (FROM ARGENTINA) HAS SCEN ELIMINATED. THEY REEP IN TOUCH WITH ONE ANTONER FHROUGH A U.S. COMMUNICATIONS INSTACLATION IN THE PANAMA CANAL TONE WHICH COVERS ALL OF LATIN AMERICA. THIS U.S. COMMUNICATIONS FACILITY IS USED MAINLY BY STUDENT OFFICERS TO CALL HOME TO LATIN AMERICA BUT IT IS ALSO EMPLOYED TO CO-ORDINATE INTELLIGENCE INFORMATION AMONG THE SOUTHERN COME COUNTRIES. THEY MAINTAIN THE CONFIDENTIALITY OF THE IR COMMUNICATION THROU THE U.S. FACILITY IN PANAMA BY USING BILATERAL CODES, IN HIS VIEW THE WHOLE METWORK IS PRACTICALLY USELESS AND SERVES MAINLY TO PERMIT CHIEFS OF INTELLIGENCE TO EXAGGERATE THEIR DAM DIMINISHING IMPORTANCE.

4. COMMENT, DEVIOUSLY THIS IS THE CONDOR METWORK WHICH ALL OF US HAVE HEARD ABOUT OVER THE LAST FEW YEARS. ALTHOUGH FRETES DAVALOS TOLD ME HE HAD ONLY MENTIONED TO PRESIDENT STROESSNER THAT WE, WERE GOING TO TALK ABOUT THE MEETING, I SUSPECT THE PRESIDENT ACTOED FRETES' STATED INTENTION OF PROVIDING ME WITH A COPY OF THE ACTA AND INSTEAD TOLD HIM TO READ IT TO HE. EITHER ! MISURDERSTOOD OR FRETES MISSPOKE IN OUR PRE-VIDUS MEETING MEFTEL) WHEN HE SAID ARGENTINA HAD ALSO

TELEGRAM ATTREBED. APPEARENTLY TWO BILATERAL MEETINGS AND ARGENTINA TOOR PLACE ONE AFTER THE OTHER AND SOME

SESSIONS MAY EVEN HAVE OVERLAPPED.

S. RECONNENDATION: THE TWO FRE AGENTS HERE TELL ME THERE IS LIKELIHOOD CONDOR WILL SURFACE DURING LETELIER TRIAL IN THE U.S. IF GENERAL FETTS DAVALOS IS ACCURATE IN BESCRIBING THE COMMUNICATIONS IT USES AS AN

ENCRYPED SYSTEM WITHIN U.S. COMMUNICATIONS HET TAND I MAVE NO KNOWLEDGE WHETHER THIS IS TRUED, IT WOULD SEEN ADVISABLE TO REVIEW THIS ARRANGEMENT TO INSURE THAT ITS CONTINUATION

IS IN U.S. INTEREST.
